




End Cap has to be field cut to roof pitch. The dotted line illustrates cutting to the 6/12 pitch indicator on End Cap.

### **ROOF PITCH GREATER THAN 5:12**


Remove two bottom rivets before installing drain. Attach drain to end cap with pop rivets or lap screws.




Illustration for Multi Unit Splice Installing Drain
