**Size:** The Mueller endwall louvered vent is available in over 30 designer colors and comes in the following sizes: 12" x 18", 2' x 2' and 3' x 3'.

**Design:** Aerodynamic, low-profile design enhances the appearance of your building. The endwall vents are made to provide a source of inflow air to exhaust through Mueller's low-profile or commercial ridge vents. This complete ventilation package provides your Mueller metal building with a dynamic air cycle to reduce heat buildup.

**Construction:** A Mueller endwall louvered vent is factory assembled for the customer. It is produced from 26-gauge, grade 50 material (50,000 min KSI yield point) for a durable, long life while exposed to the elements.

**Finish:** Our wall louvered vents feature durable, steel construction and a top-quality paint coating, complementing every Mueller panel type and paint finish. There are over 30 designer colors to choose from to get the look you desire.

**Benefits of Ventilation:** One of the most overlooked components of design and installation of architectural roofing systems is ventilation. A properly engineered ventilation system using ridge vents, in conjunction with an under soffit intake and endwall louvered vents, will provide air movement through the roofing system to remove air. Convection removes summer heat, which reduces cooling bills and extends the life of the roofing system. In winter, proper ventilation will assist in the control of condensation that can lead to problems such as rust and insulation degradation.

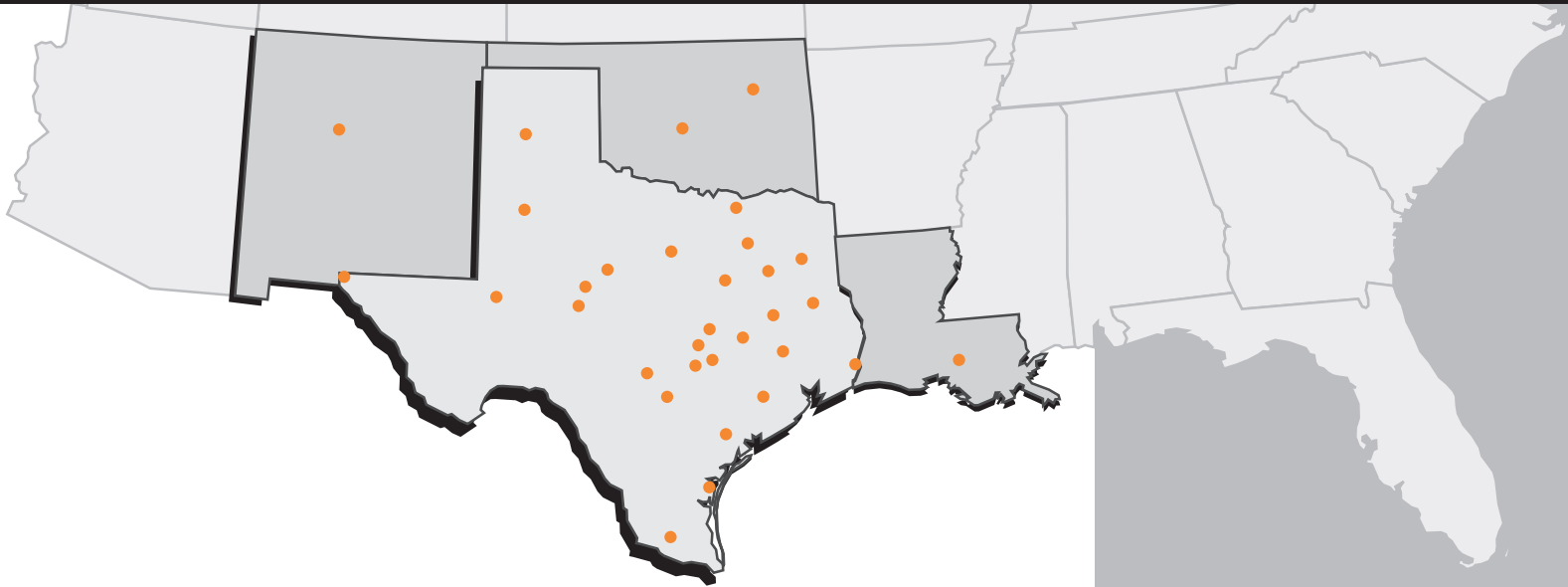

Notification. Buyer must notify Mueller, Inc. of defective material or workmanship within 30 days of discovery of the defect. Mueller, Inc. shall investigate and make a determination of coverage under this warranty. If materials or workmanship are deemed defective per generally accepted industry standards, Mueller, Inc. will provide one of the aforementioned remedies within 90 days from the date notice of defect is provided to Mueller, Inc.
